If we are not notified by this time, your usual daily charges will be incurred as staffing levels are regulated by the number of students expected each day

If you wish your child/children to attend on a casual basis, a message needs to be left on the above number above by 7 am for BC or 1:00pm for ASC.

Once again, this is to ensure that acceptable supervision ratios are reached. We cannot accept casual students who come over to us after school where parents have not left a message.

All enrolment information will be kept private and confidential, with an exception if there are safety concerns and for MSD audit purposes.

I understand that if I have reserved a regular place and my child is unable to attend on that day, a text must be sent to 027 7278976 before 7.30 pm the previous night for BC & 1pm that day for ASC. If I do not send a text by these times advising of an absence I understand that my usual daily charges will be incurred as staffing levels each day are regulated by the number of students expected.

I agree to pay the charge of \$1.00 per minute for any early drop offs being before 7am/late pick-up being after 6.00pm, the closing time of the programme.

Our organisation is committed to keeping children healthy and safe. We may share information with appropriate agencies (such as health and education providers or other agencies involved with your child's life) if sharing that information will protect or improve the safety, health or well-being of a child. Our agency by law can always share information with CYFS and the Police.
